- Possess working knowledge of YMCA mission, purpose and goals, childcare policies and YMCA standards; clearly and effectively communicate to parents, principals and program participants; promote other YMCA programs
- Follow licensing and school procedures

Qualifications:

- At least 18 years of age with documentation of high school diploma/equivalent
- At least 80 hours of Early Childhood classes with documentation **and** completed at least 18 credits in elementary education, child guidance or child development
- 1 year of experience working with children in a formal setting is required
- Provide documentation or able to obtain w/in 30 days of hire the following certifications: American Red Cross, CPR for the Professional Rescuer, First Aid, Shaken Baby
- At time of hire, must be able to furnish the following documents: signed state document indicating a current Tuberculosis test and physical exam, transcripts, credentials and additional completed certifications

- Ability to follow required licensing procedures including, but not limited to: adherence to “sight and sound” child guidance, resolve conflict, effectively communicate with diverse groups, demonstrate a passion for children
- Must be able to travel to alternate school locations as directed by Region Director due to ratio needs
