Born and raised in Chicago, IL having attended the University of Northern Iowa, Judge Mosley received his J.D. from Marquette University Law School. Appointed by the Milwaukee Common Council to fill the vacancy in Branch 2 starting on August 1, 2002, from 1995 until his appointment to the bench, he served as an Assistant District Attorney for Milwaukee County, where he represented the State of Wisconsin in over 1,000 criminal prosecutions. These cases included felonies, misdemeanors, traffic cases and juvenile delinquencies. He served as the Court's Presiding Judge from 2004 - 2012. His community activities include sitting on the Board of Directors of a number of non-profit organizations, serving on the State Bar of Wisconsin's Public Trust & Confidence Committee, Public Image Committee and the Minority Recruitment Committee.

He is married to Kelly Cochrane and has two daughters; Kallan and Kieran.
